The Worth Park District Board of Park Commissioners is seeking to fill one seat on the Park District's Board of Park Commissioners that became vacant on November 10, 2021. The Board of Park Commissioners will consider all interested residents who are registered voters of the Worth Park District. The term of the appointment will be from December 15, 2021 until May 2023.

Commissioner Information

Park District Commissioners are elected by the Worth Park District voters to serve six year terms under ordinary circumstances. When a position becomes vacant, the Board of Park Commissioners may appoint a resident to fill the vacant seat until the next regularly scheduled local consolidated election. In this instance, the term of office for the vacant seat is until May 2023. To fill the vacancy, the Board plans to appoint an individual from December 2021 through May 2023. An election will be held in April 2023 for residents to elect an individual to a new six-year term.

Park Commissioner Responsibilities and Requirements

Government of the Worth Park District is vested in the Board of Park Commissioners, which consists of five elected or appointed members. The members of the Board constitute the corporate authority governing the Park District pursuant to Illinois law.

The Park Board has the authority to make all decisions affecting the operations of the Park District, but normally exercises its power by establishing policy and reviewing the implementation of policy by its officers and employees. In addition, the Board shall perform the following functions:

- a. Adopt policies that allow the organization to run efficiently, effectively, legally and ethically.
- b. Request, receive, evaluate and make decisions based on well researched guidance from the Director.
- c. Interpret the agency's mission, values and vision to the public.
- d. Monitor operational and capital finances.
- e. Hire, supervise, evaluate and support the Director.
- f. Establish policies after consideration of the pros and cons of each issue.
- g. Help set a strategic direction that adopts goals relating to the vision and mission of the organization.
- h. Act as a resource, sounding board and as the eyes and ears of the citizens of the community, making sure that the Park District is meeting their needs.
- i. Develop, maintain and update long-range plans.
- j. Adopt and adhere to a code of ethics.

Time Commitment

A member of the Board of Park Commissioners has demands upon their time. The following items outline generally what the time commitment entails:

- a. Two monthly Board Meetings. The Committee of the Whole meeting and the Regular Board meeting is on the third Wednesday of each month. Meetings are held at the Terrace Centre at 6:00 PM and generally last between one and two hours.
- b. Prior to each meeting a packet of information is provided. Board members are expected to review all the materials in advance of the meetings.
- c. Communicating with residents both formally and informally.
- d. Attendance at facilities, programs and special events.
- e. Attendance at the state association conference each January for one or two days is optional.
